This month I asked our new Sergeant at Arms to tell us a little bit about himself and his time in the Marine Corps. Here's what he had to say...

I was born and raised in the Bronx, New York. The youngest of eight children, six boys and two girls. My father was a United States Army Tank Commander in the Korean War. Three of my brothers served as United States Marines; two of the three were in the Gulf War. The two remaining brothers served in the United States Navy and are also veterans of the Gulf War.

I graduated from the prestigious Cardinal Hayes High School and continued my education by enrolling into John Jay College of Criminal Justice while working as a clerk for the Federal Department of Probation. I joined the Marine Corps at the age of 22 as a 0331 Machine Gunner. I participated in several real-world operations such as Operation Dynamic response (Kosovo), Operation Iraqi Freedom (Nasiriyah Iraq), and Operation Enduring Freedom (Djibouti, Africa and Afghanistan). By the end of my service, I had finished my training and was deemed a Nuclear, Biological and Chemical NCO E4 Machine Gun Squad Leader.

After being injured in Iraq I moved to Orlando, Florida where I became a Juvenile Detention Officer followed by a Master Correctional Officer for Orange County for ten years. I married my longtime childhood sweetheart from my hometown in the Bronx, New York. From there we lived in Augusta for two years where I received my Associate Degree of History while attending Georgia Military College. We currently reside in Pittston, Pennsylvania and are expecting our first child. My ambition is to continue my education and obtain my master's degree in history in the near future.


